

#### Detroit - Michigan

The Detroit Unit of the National Association of Parliamentarians held its annual workshop, "All Things Done Decently and Orderly According to Henry M. Robert, III," on Saturday, May 23rd at the Charles H Ellis Conference Center, Greater Grace Temple, in Detroit. Presentations by President Jewel Johnson Jones, RP, Vivian Tansil, and Julia Boayue, PRP were very well received.

Students from Detroit's Breithaupt Career and Technical Center were on hand to demonstrate their parliamentary skills used to capture both first and second place in statewide SkillsUSA parliamentary procedure competitions. The first place team was honored and are shown with Govenor Rick Snyder following the final competition held in Lansing. The first place team advanced to compete in national SkillsUSA competitions held in Tennessee.

Kudos to Mrs. Angel Glenn, Lead Instructor at Breithaupt; and, to Rev. Robert Neal and Julia Boayue, PRP from the Detroit Unit who coached the winning teams. Congratulations! Also, in recognition of April as Parliamentary Law month, on Thursday, April 30th from 6-7p.m. the Detroit Unit of the National Association of Parliamentarians, in cooperation with the Michigan State Association of Parliamentarians (MSAP), Wayne County Clerk Cathy Garrett's Office, and several other loyal supporters, hosted a small dessert re-ception. and gifted four (4) books about Robert's Rules of Order and parliamentary procedures, at the Chaney Branch of the Detroit Library.

The presentation of two (2) copies of Robert's Rules of Order Newly Revised (11th edition) were gifted in memory of Mrs. Grace Banks and Ms. Ola Bush who were members of both the Detroit Unit and Michigan State Association of Parliamentarians. Two (2) copies of Robert's Rules of Order Newly Revised in Brief (2nd edition) were gifted in memory of Baba Chimba Omari and DaVante Lawson. DaVante Lawson attended parliamentary procedure youth workshops sponsored by MSAP and was a student at Southwestern High School, and member of the Patton Recreation Center Teen Council.

The event is representative of the Detroit Unit's collective and continuing efforts promoting the vision of the National Association of Parlimentarians, to "provide parliamentary leadership to the world."

#### Louise Saks Parliamentary - Michigan

One of the most delightful aspects of attending this convention was having friends there, a full contingent of unit delegates! There were lessons to be learned around every corner, some in workshops and private conversations and many in business meetings.

There were bylaws proposed that would have changed NAP considerably but before we could deal with the twenty-two proposals we began with basics—credential report, convention standing rules, and adoption of the program. In spite of snafus with credentials during the registration process in which LSPU among many other units who had sent their delegate lists by the deadline were not on record, the credentials report was approved without amendment.

The convention standing rules were quite another matter. There were several unusual ones, including one that made all questions of privilege be submitted to the convention coordinator, not to the presiding officer as privileged motions. The convention coordinator opposed this option as well as a number of people who wondered about losing their vote in the event a keypad didn't work or they couldn't locate the convention coordinator.

In all, seven of the thirteen standing rules were pulled for individual consideration, and though people later groused about the hours it took to approve the standing rules, the objections raised to them had a major impact on the running of the entire convention, especially in relation to the election rules. In the same way, a change in the program that put the election before the bylaws consideration, was significant.

"Only" sixteen of the bylaw amendments were handled before the convention adjourned. The assembly did approve having the two directors who will serve on the Board, being elected by the entire assembly. The proposal to have an annual membership meeting rather than a convention did not pass. The proposal to require the president and vice-president to have had five years of consecutive PRP status along with having served two terms on the Board did not pass. The proposal to eliminate the membership exam as a qualification for being an NAP member did not pass. The proposal for a national provisional member did not pass. The limitation on the president and vice-president serving one term remains in the bylaws.

President Ann Guiberson was an able presider who graciously accepted challenges to her decisions, especially when made by two authors of *Robert's Rules of Order, Newly-Revised*.



Kalamazoo Parliamentary Law – Michigan Julie Pioch's interim position as district coordinator for Michigan State University Extension's sevencounty District 13 has been made permanent, effective September 1.
