MAP TO PROVIDING A GREAT OPINION: PRODUCING A POSITIVE OPINION

The ability to write an effective parliamentary opinion is an expected skill of a Professional Registered Parliamentarian. This session will focus on analyzing the questions the opinion is to answer, researching and problem solving that leads to those answers, and formatting the opinion in a professional manner.

Attendees will receive guidance that will prepare them to fine-tune their parliamentary opinion writing skills. (BOK Domain 7)

Nancy Sylvester has a master's degree in communication from the University of Michigan and is Professor Emeritus of Speech at Rock Valley College where she taught for 31 years. After participating in this session, participants will be able to explain the rules governing each motion and their differences, vote requirements, notice, and how each is considered.

HONOR AMONG THIEVES: FIDUCIARY RESPONSIBILITIES OF THE BOARD

PIRATES' CODE

C.J. Cavin, JD, PRP, CPP-T

In this session, attendees will gain an in-depth understanding of the purpose of the Code for Professional Responsibility of Parliamentarians (COPRP), including possible violations, the complaint process, and hypotheticals. (BOK Domain 5, Professional Responsibility)

Participants will be able to describe the background and approach to applying COPRP as described in *Professional Practices in Parliamentary Procedure* page 67 through the section entitled "Acting Professionally" on page 75, while recognizing that there have been changes in The Code since that commentary was published.

They also will be able to respond to scenarios on ethical dilemmas based upon COPPRP and identify, at least in paraphrased form, the 15 items in COPRP of which violations are subject to discipline under "Complaints Related to Member Discipline" given in *Professional Practices in Parliamentary Procedure* page 75.
